**HIGH RISK SCENARIOS IN ADMINISTRATIVE ADJUDICATIONS**  
**and**  
**HOW TO HANDLE THEM**

The 2023 SATA Spring Conference will focus on issues that arise in the context of administrative adjudications that can commonly lead to decisions being overturned. Seemingly minor decisions made during the course of an adjudication can end up generating a decision that cannot withstand appeal. A series of experienced presenters will flag common “high-risk” scenarios and equip conference attendees with the tools needed to work through them with a view to making high quality decisions.

Among the common high-risk scenarios that will be discussed will include:

- Adjournment requests – to grant or deny;
- Handling hearsay evidence;
- Tribunal acting outside of authority;
- Questioning by adjudicators;
- Adjudicators with prior positive or negative connections with the parties;
- Accommodating the needs of self-represented parties;
- Handling vexatious approaches to litigation.
